#### **New Regulations Website**

The Canada Organic Office of the Canadian Food Inspection Agency (CFIA) today published its new Organic Products Regulations website, featuring essential information on the upcoming regulations and enforcement policy, including:

- **1.** An official list of Conformity Verification Bodies (accreditors) which have applied to the agency to carry out the assessments of Certifiers under the new program:
- **2.** A draft Stream of Commerce and Enforcement Policy, describes how the CFIA will enforce products over the initial 24 months following implementation.

The website also includes valuable resources, such as a copy of the government's cost benefit analysis for regulating the organic sector, questions and answers on the 2009 organic regulations, links to the regulations, standards and Canadian statistics.

OMRI reports to certifiers any product names removed from the OMRI Products List within ten days of their removal. OMRI 'drops' products when the companies voluntarily request their products be removed from our

program or they fail to comply with the organization's policies. OMRI prohibits products only when conclusive evidence is on file to demonstrate a non-compliance with the NOP Rule. The following products have been removed from the OMRI Products List recently:

## **EPA Will Test Pesticides' Effect on Endocrine System**

The chemicals, known as endocrine disruptors, may interfere with the hormones that humans and animals produce or secrete

The Environmental Protection Agency announced today it will order pesticide manufacturers for the first time to test 67 chemicals contained in their products to determine if they disrupt the endocrine system, which regulates both animals' and humans' growth, metabolism and reproduction.

Researchers have raised concerns that chemicals released into the environment are interfering with animals' hormone systems, citing problems such as male fish in the Potomac River that are growing eggs. The chemicals, known as endocrine disruptors, may interfere with the hormones that humans and animals produce or secrete.

"Endocrine disruptors can cause lifelong health problems, especially for children," said EPA Administrator Lisa P. Jackson in a statement. "Gathering this information will help us work with communities and industry to protect Americans from harmful exposure

#### From Bell Labs - Quintox

We had a conference call with PMRA. As a result of the conference, we are releasing the following statement regarding our plans to ultimately register Quintox (organic formulation) in Canada.

Note from registrant to Canadian pest control experts:

The active ingredient in Quintox (cholecalciferol), also known as Vitamin D3 is known to be a low risk compound. Any safety or regulatory concerns by governments and users have been around the formulation of the product - not its active. Bell Laboratories, Inc. has therefore decided to reformulate the active ingredient into a low risk product that is acceptable to conventional and organic markets. The new formulation has recently been registered by the USEPA for structural uses. Bell s exploring the possibility of registering this product for use in agricultural crops as well. Parallel to these actions, Bell will be in communication with the regulatory authorities in Canada for a registration submission.
