ALR Consultation Period Closes August 22

The BC Ministry of Agriculture is conducting consultations regarding the changes to the ALC act until August 22. Everyone is encouraged to participate.

The Ministry states that "the consultations with B.C. farmers will inform the drafting of regulations related to Bill 24."

Minister of Agriculture Norm Letnick met with representatives from the B.C. Agriculture Council (BCAC), the Union of British Columbia Municipalities (UBCM) and the Agricultural Land Commission (ALC) to discuss the consultation process in early July. The questions identified as key for the consultations, are listed on the consultation website, http://engage.gov.bc.ca/landreserve. input can be submitted through the above website or through the dedicated email address, ALCA_Feedback@gov.bc.ca

Online submissions will be the only way for the general public to give input to the formation of the regulatory changes.

OrganicInputs.ca Becomes the Main National List of Approved Inputs

In the spring of 2014, the Atlantic Canadian Organic Regional Network (ACORN) and the Pacific Agricultural Certification Society (PACS) agreed to support OrganicInputs.ca as the main national inputs directory, in replacement of their own inputs lists. An ACORN staff member said, "Supporting this national tool makes sense. Having a unified directory of approved inputs for organic production saves valuable time and ensures that the information stays current and relevant to the needs of the site users." And from the PACS Certification Committee; "We get lots of enquiries from manufacturers interested in listing their products and we have referred all of them to OrganicInputs.ca for a long time now. We really like the website and find it easy to use." All of the products in the OrganicInputs.ca directory are either approved for use or have been found compliant according to the Canadian organic standard by an Organic Certification Body or the Organic Materials Review Institute (OMRI).

The directory is more than just a list of products, it is an educational tool. By typing in a problem into the search bar, organic producers and gardeners can find solutions to a large range of production challenges. With over 700 products in the directory, including soil amendments, pest management products as well as cleaners and sanitizers, site visitors have a great selection of products to choose from.

Draft of National Standards for Organic Production: Now Available for Public Review

Since the fall of 2013, the Working Groups (WG) and the Technical Committee on Organic Agriculture (TC) have been working on the review of the Canadian Organic Standards. Proposals for revision were received from many members of the organic sector. Each proposal has been carefully reviewed according to the requirements set out in Section 10 of CAN/CGSB-32.310 General Principles and Management Standards and in accordance with the procedures established by the Canadian General Standards Board (CGSB).

The draft amendments are now available for a period of 60 days for public review from July 22, 2014 to September 22, 2014.

Organic Processing Inspector Course

Date: Nov 10-14, 2014

Location: Mississauga, Ontario

Cost: \$1750

The course includes comprehensive training on the Canadian Organic
Standards and four days of instruction including a field trip to a certified organic operation, plus one-half day for testing.
Core instruction includes: how to conduct processing facility inspections, applicable organic certification processing/handling standards, regulatory requirements, audit control, HACCP/Organic Control Points, structural pest management, sanitation, ingredients, labeling, inspection report writing, communication skills, and inspector protocols. Date: Nov 14-16, 2014


Location: Kwantlen Polytechnic University, Richmond, BC

REMINDERS

ISO operators are fortunate to be able to use the Canada Organic label AND the BC Checkmark side by side.

The logo of the BC Certified Organic program is a key tool to identify certified organic products in BC. It is important that the symbol is used correctly; here is a quick reminder, especially for websites and the exclusion zone (white space.)



The Program Symbol is enclosed by a black border. The border ensures that the appropriate white space or exclusion zone is provided around the composite mark. The Program Symbol must be enclosed by the

border if the Symbol is applied against colored or complex backgrounds. However, if the background is white or off-white, it may be desirable to omit the border while ensuring the appropriate exclusion zone.


