The 2014 COABC conference being held at the Coast Bastion Inn in Nanaimo, BC, February 21st – 23rd, will feature many practical sessions and networking opportunities.



Melissa Coleman is the Keynote speaker and will talk about her book 'This life is in your Hands'. In the book, Melissa discusses growing up with one of the organic pioneers.

Her father, Eliot Coleman, is one of the most influential organic farmers in the country, a trailblazer in the locavore and the whole food movements.

In addition to having Melissa Coleman as our keynote speaker, COABC is fortunate to offer a session from Clara Coleman as well.

Clara is a second-generation American organic farmer, consultant, writer on sustainable four-season farming and also the daughter of renowned farming pioneer Eliot Coleman.



Clara has produced year-round vegetable crops under harsh winter conditions, using unheated and minimally heated moveable high tunnels or greenhouses and like her father, she is a proponent of the 'small is better' model of farming.

Organic sector invited to submit requests for modifications to the Canadian Organic Standards (COS)

The Review of the COS is underway, and all sections of the organic standards have to be revised. The review will take 2 years with the aim to publish the revised standard in 2015.

Members of the Technical Committee and the Conveners of the Working groups, responsible for the review, are ready to hear the sector's concerns about the Canadian standard.

You must carefully describe the modification that you are proposing and provide adequate background information.

Before submitting a request, consult the Final Q&As section, on the OFC website as these interpretations may provide clarification.

Food for the Future! Family Day Rally to Save the Agricultural Land Reserve

February 2014 marks the 40th birthday of the Agricultural Land Reserve (ALR), created to protect farmland across BC for agriculture. Only 5% of the landbase of our mountainous province is protected in the ALR, and now the BC Government is considering drastic changes to erode the reserve and the autonomy of the commission entrusted to protect it.

British Columbians from all walks of life need a reliable supply of farmland to grow food now and for the future – particularly as the benefits of local food systems and the challenges of global transport become clear.

REMINDERS

ISO operators are fortunate to be able to use the Canada Organic label AND the BC Checkmark side by side.

The logo of the BC Certified Organic program is a key tool to identify certified organic products in BC. It is important that the symbol is used correctly; here is a quick reminder, especially for websites and the exclusion zone (white space.)



The Program Symbol is enclosed by a black border. The border ensures that the appropriate white space or exclusion zone is provided around the composite mark. The Program Symbol must be enclosed by the

border if the Symbol is applied against colored or complex backgrounds. However, if the background is white or off-white, it may be desirable to omit the border while ensuring the appropriate exclusion zone.
